#### PAYING TRIBUTE TO MANU CHOUDREE





The sudden passing of Manu Choudree, a gentle giant in the security industry, has sent shockwaves throughout the Southern Peninsula, and for us in Simon's Kloof, his presence will be deeply missed.

Manu was a friend of Simon's Kloof who worked tirelessly with his team to ensure that our neighbourhood has benefited from low security incidents.

# NO, IT'S NOT YOUR DOORBELL... IT'S THE JUBILEE SQUARE CLOCK



The clock, which is situated in the cupola \* of the building on Jubilee Square commemorates the Diamond Jubilee of the accession of Her Majesty Queen Elizabeth II on 6<sup>th</sup> February 1952.

In 2012, STADCO repaired and updated the mechanism and in 2024 the chiming was introduced. The clock itself is independently driven from the chiming. Both are driven from hardware and a computer situated in the STADCO offices on Jubilee Square.

The clock chimes on the hour between 7am and 6pm daily.

\* Cupola: rounded dome forming or adorning a roof or ceiling.

# A GUIDE TO COMBATING INVASIVE ALIEN VEGETATION by Mandy du Plessis

Understanding the importance of clearing alien vegetation is vital for preserving the biodiversity, water resources, and safety of Simon's Kloof. Through combined efforts of legislation, community action, and innovative projects, we can each individually play a role in mitigating the impact of invasive species and restore the health of our own natural environment. The risk of property destruction by fire involving alien vegetation is significantly higher compared to that of shrubland. Evidence also indicates a significant increase in fires globally, with fire management strategies now essential for survival in many cases.

Western Cape Alien Vegetation has a variety of alien plant species that pose threats to its ecosystems, with the most problematic including Port Jackson, Black Wattle; Rooikrans; Pine Trees, Hakea; Eucalyptus or Gum Trees.

#### Alien vs Invasive Alien Vegetation?

Alien vegetation refers to plant species that are not native to a particular ecosystem and have been introduced, either intentionally or unintentionally, by human activities. Invasive alien vegetation goes a step further;

- these are alien species that spread aggressively, outcompeting native plants for resources and disrupting local ecosystems.
- Invasive alien plants can cause significant environmental, economic, and social impacts:
- are highly adaptable, vigorous growers that invade ecological areas
- have invaded 10 million hectares of land (size of KZN)
- use 3.3 billion cubic meters of water more than their indigenous counterparts
- threaten our rich biodiversity by replacing indigenous and endemic vegetation, resulting in a loss of insect species dependent on these plants and in turn a loss of birds, reptiles and mammals who feed on these insects
- exacerbate significantly the intensity of fires, flooding, erosion, siltation and other environmental concern

Shark Spotters, with their extensive 21-year experience in human-wildlife conflict, will now assume control of baboon monitoring in Simon's Town. This transition ensures that all existing NCC staff, and any other incorporated groups, will operate under Shark Spotters' direct supervision, eliminating external influence. Shark Spotters are committed to improved community communication and Residents are encouraged to report any misconduct by "baboon flaggers" through the CoCT's C3 system.

This new management structure, under Shark Spotters, promises a more cohesive and effective approach to mitigating human-baboon conflicts in Simon's Town.

All existing staff will be retained, ensuring continuity and stability. With 20 years of experience in human-wildlife conflict resolution alongside the City of Cape Town, Shark Spotters brings a holistic approach that integrates research, education, and active management. They're committed to collaboration, aiming to reduce conflicts between both baboons and communities, and among community groups themselves.

# IT'S SUNDAY, AND THE PERSON NEXT DOOR IS RENOVATING .....

#### YOUR RIGHTS WHEN A NEIGHBOUR WANTS TO RENOVATE



The Regulations issued in terms of section 17 (1) of the National Building Regulations and Building Standards Act 103 of 1977, prohibit the use of machinery, engines, apparatus, tools or contrivance which may cause a disturbance to the neighborhood:

- on a public holiday or Sunday;
- before 06:00 or after 17:00 on any Saturday; and
- before 06:00 or after 18:00 on any day other than those days above.

These are strict timelines which can be enforced by engaging the relevant law enforcement authorities.

However, your neighbour is within his rights to proceed with such works outside of these times if:

- the work is required for an emergency to protect life or property; or
- the work is being done on behalf of a public authority; or
- the local authority (for example, your City's Development Management Department) has granted its permission to proceed with the work.

If your neighbour is building at the early hours of the morning or on your (supposed-to-be) serene Sundays and he is not able to prove that any of the requisite exceptions to the regulations apply, certain remedies become available to you as an affected party. Such relief is based in terms of the relevant By-laws in our area, such as the City of Cape Town's Municipal Planning By-law and the Streets, Public Places and Prevention of Noise Nuisance By-law which is exclusively applicable to the City

**TO REPORT A DISTURBANCE**: the call centre is available 24/7, you can report noise to the Public Emergency Community Centre (PECC) on 107 from a landline or <u>021 480 7700</u> from a cell phone.

### DOGGIE DOO AND LEADS

Keeping our community clean and safe is a shared responsibility. Simon's Kloof is officially a DOG POOP FREE ZONE! Including all flower beds, reservoirs, streets and pavements!!

Please remember to pick up after your dogs during walks. As Dog waste not only creates an unpleasant environment but also poses health risks. Ensure you always carry bags and properly dispose of them.

Additionally, for the safety of everyone, including your furry friends, please keep your dogs on leads while walking in public spaces.
